Prior to that he held CFO and VP Finance positions at several publicly traded companies, including Memco Software Ltd, Bogen International Inc. and Aryt Industries Ltd. listed on Nasdaq. Dov is a Certified Public Accountant (Israel) and holds a B.A. in Economics and Accounting from Ben-Gurion University, Israel.

Yossi Vadnagra has been working with SHL in both international and domestic Business Development functions and was appointed CFO in June 2017. He will assume the function of General Manager of SHL's operations in Israel that is currently performed by the company's CEO.
