# SHL Telemedicine announces transformative, accretive acquisition of majority stake in Mediton Group, a leading B2B healthcare services provider in Israel

The acquisition contributes to all of SHL's financial parameters from day one

- Mediton Group is profitable and growing, with strong B2B healthcare offering business that is complementary to SHL's Israel B2C business
- The acquisition doubles SHL's annual revenues in Israel to a level of NIS 140 150 million (USD 43 – 46 million) and EBITDA of NIS 45-50 million (USD 14 – 15.5 million)
- In 2021, Mediton Group is expected to generate revenues of NIS 65 70 million (USD 20 – 22 million) and EBITDA of NIS 20 – 22 million (USD 6 – 7 million)
- SHL expects that the synergy from the acquisition will increase its annual revenues in Israel to NIS 185 200 million (USD 57 62 million) within 3 years

**Tel Aviv / Zurich, 25 August 2021** – SHL Telemedicine Ltd. (SIX Swiss Exchange: SHLTN), a leading provider and developer of advanced personal telemedicine solutions, today announced it has signed an agreement to acquire 70% of the Mediton Group companies. The acquisition is accretive to SHL as of day one.

The Mediton Group with its 220 employees is a leading provider of B2B healthcare services in Israel in the field of diagnostics, preventive medicine, and medical opinions to institutional customers, including Israeli blue-chip companies, government institutions including the Israeli Social Security and Ministry of Defense, all four sick funds and to insurance companies.

SHL Telemedicine will acquire a 70% interest in Mediton Group for approx. USD 26 million (NIS 84 million) on a cash-free debt-free basis adjusted by net working capital and will finance the acquisition from cash on hand and long-term bank financing. The transaction has a put and call option that will allow the transfer to SHL of the remaining 30% interest in approximately four to five years from closing. The Mediton Group will continue to operate under its current leadership.

The agreement contains customary sellers' reps and warranties, as well as sellers' indemnification, non-compete and non-solicitation undertakings. The transaction is expected to close within 30 days subject to satisfaction of customary closing conditions.

"Following the capital increase earlier this year, this is a major step in our ambition to significantly grow SHL Telemedicine. The passion and dedication of the Mediton Group leadership team makes it the perfect company to expand our footprint in the Israeli market to the B2B healthcare services offering, continuing to implement our growth strategy in all our territories," said Mr.
