## **SHL Telemedicine announces appointment of a new CFO**

Prior to serving as the Chief Financial Officer at Radcom Amir Hai served as Chief Financial Officer for several multinational companies including a Nasdaq traded optical manufacturing corporation and a software company traded on the Frankfurt Stock Exchange. He also served as external director and Chairman of the Audit Committee to Matrix I.T. Ltd. Amir Hai holds a BA degree in accounting and management from The College of Management in Tel Aviv and is a Certified Public Accountant in Israel.
